Subject: Exercise of rights afforded by Series A subscription warrants and acquisition of Series L shares

Legal basis: Art. 56 section 1 item 1 of the Offerings Act – confidential information

In reference to Current Report no. 2/2016 of 29 January 2016, the Management Board of CD PROJEKT S.A., headquartered in Warsaw, Jagiellońska 74 (hereafter referred to as “the Company”) hereby announces that on 11 March 2016, having exercised the rights afforded by Series A subscription warrants, some of the entitled parties duly submitted written declarations of intent to claim Series L shares. Altogether, 120,000 Series L shares were claimed, which is 41.38% of the total number of shares afforded by subscription warrants which had previously been assigned in light of the attainment of the market goal of the incentive program in force at the Company.

The rights afforded by the aforementioned Series L shares will become active on the day the Shares are deposited into the entitled parties’ respective securities accounts.
